

IBC 2019 fastest lap competition

Terms and conditions

1. The Competition is open to those aged 18 or over, other than employees of BT their families or its agencies. Only one entry per person.
2. The Promoter reserves the right to verify the eligibility of entrants and check their identity.
3. The prizes and associated conditions are as follows:
 - Winner: 2 Grandstand tickets to a Moto GP of their choice. The T's and C's of each circuit can be found on the circuit website. Everyone accessing the circuit must comply with the circuit rules. The prize does not include any travel expenses, or accommodation.
